Tests of soundness are based upon three categories – procedural, consistency, coherence and effectiveness.

While the strategy does appear to fulfil adequately the required Procedural Tests

and Consistency tests the evidence base and absence of presentation of an in-depth analysis of key matters means it des not offer a robust case that it fulfils all the Coherence and Effectiveness tests, including 'setting out a coherent strategy from which its policies and allocations logically flow and where cross boundary issues are relevant' Nor does it demonstrate on the basis of robust evidence 'the strategy, policies and allocations are realistic and appropriate and are founded on a

robust evidence base'. It lacks specification of 'clear mechanisms for implementation and monitoring'; and it also fails to demonstrate it is 'reasonably flexible to enable it to deal with changing circumstances'.
